CONDITIONS OF ACCESS

The Bunkers Conservation Reserve, BCR, is an environmentally sensitive area. All flora and fauna on the BCR is protected, please minimise your impact by 'treading lightly and leaving no trace'.

1. Access to the BCR is only possible with the attendance of a YFRWPA member-host present. Their role is to host the group by giving access to the Davey Hut campground and the essential services of water, power and communications. Their stay will be independent to the group's requirements.
2. Group leader(s) take responsibility for the conduct of their group's actions with regard to the protection of the environment and infrastructure within the BCR.
3. Camping is only permitted at the Davey Hut campground and nowhere else on the BCR.
4. Campers have shared access to the camp-kitchen, please ensure the area is tidy and all surfaces and equipment cleaned after each meal period, rubbish including food scraps should be contained to minimise pests, bottled LPG is included.
5. Vehicles shall only use existing tracks at all times.
6. All drivers shall hold a current drivers licence.
7. All water must be used sparingly due to our restricted supply (vehicle washing is not permitted).
8. Showers use bore water and only require a small fire to heat the donkey boiler.
9. The Fire Danger Season generally runs from November through to April, although these dates may change due to seasonal conditions, the exact dates are published prior to the Fire Danger Season, please familiarise yourself with the [Flinders Fire Ban District](#) before arrival.
10. Strictly no fires on a Total Fire Ban Day.
11. A wood fire may be lit for cooking or heating with a responsible person in attendance at all times with water nearby in case of an emergency.
12. Camp fires are only permitted at the Davey Hut campground and nowhere else on the BCR.
13. Please only light fires in the designated fire pits, donkey boiler and pot belly stove.
14. Firewood collection is not permitted on the BCR, camp fire wood is included.
15. Please only light fires when required and never leave a fire unattended, all fire pits to be extinguished with water and cleaned when vacating camp.
16. All rubbish must be removed when leaving the BCR and disposed of properly
17. The toilet system is a closed system, only toilet paper and biodegradable items to be flushed down the system, items like hand/face wipes and sanitary products must not be put into the system and should be placed in your rubbish.
18. Use of electricity should be sparing, please unplug all devices when not in use.
19. Please keep all noise to a minimum and always respect other campers, offensive behaviour and language will not be tolerated.
20. Smoking is not allowed in any undercover areas, please dispose of your butts properly.
21. Pets of any sort are not allowed.
22. Firearms are strictly prohibited.
23. Hunting in any form is prohibited.
24. Please note the YFRWPA, through the member-host present, reserves the right to remove any persons who fail to camp by the above conditions.

PAYMENT

- All payments are to the YFRWPA to access the BCR for the purpose of a small group camp and use of the Davey Hut campground facilities and services.
- The agreed payment needs to be transferred in full 30 days before accessing the BCR.
- Should circumstances change in the lead-up to your booking dates, the payment is 100% refundable up to 48 hours before access.
- After 48 hours the payment can be rolled over to a future booking, otherwise a small admin fee may need to apply.

OTHER

- All groups need to provide a copy of their current public liability insurance cover for the BCR.
- If minors will be attending in your group, please enter YES in Police Clearance box to confirm that all adults attending the Reserve have a current Police Clearance.
